

FIRST TAX CLUB QUIZ COMPETITION: PROMISE FULFILLED

All prize promises at the First Annual Tax Club Quiz Completion (TCQC) held in 2016 have been fulfilled. Prizes were given to the top 3 schools (for projects), for students (for scholarship)and for teachers (cash prizes)

Government Secondary School (GSS), Omu-Aran made history by emerging as winner of the maiden edition of TCQC, while Government Girls Day Secondary School (GGDSS) Oko-Erin and Iloffa Grammar School (IGS) Iloffa emerged as second and third respectively.

The prizes for the best teachers which were cash prizes of N150,000, N100,000 and N50,000 for the 1st, 2st and 3rd best teachers respectively were all redeemed by the beneficiaries after the competition in December, 2016. The scholarship prizes for tertiary education won by students at the values of N250,000, N150,000 and N100,000 for 1st, 2nd and 3rdbest. As the students who represented their schools have begun to gain admission into tertiary institution, redemption of prizes for the students has also commenced.

The prizes for the best schools have all also been redeemed. The winning School GSS Omu-Aran won a prize worth N1, 000,000 while the second and third schools won N500,000 and N250,000 respectively. As resolved by the two organizing parties KW-IRS and the ministry of Education, the prize winning were to be used for projectsthat will add value to the educational experience of the students of the school.

The first prize won by GSS Omu Aran was used to furnish theschool library, the second prize for GGDSS Oko-Erin was used to renovate a block of classrooms while IGS, Iloffa used their winning to furnish the conference room as the third prize.

The principals, teachers, students and parents of various schools experienced joy over the donations at the handling over event.

Ministries' Collections will be Fully Automated in 2018



he Executive Chairman of Kwara State Internal Revenue Service (KW-IRS), Dr Muritala Awodun has assured all that by January 2018, all revenues that are generated by Ministries, Departments & Agencies (MDAs) in Kwara State will be fully automated which would significantly block revenue leakages being experienced in the past and improve

collections. Dr Muritala Awodun stated this during a courtesy tour at Kwara State Secretariat, Ilorin.

The Executive Chairman, KW-IRS explained that while there had been various engagement between the Ministries and the Service for the design of the platform to transition from manual to automated

KW-IRS Seals Skye Bank in Horin

he Kwara State Internal Revenue Service (KW-IRS) sealed two branches of Skye Bank in Ilorin, the Kwara State Capital on Wednesday 24th January 2018. The KW-IRS team was led by the Director, Legal and Enforcement, Lateef Okandeji, Esq. He said this was an enforcement of a Court Order issued on 23rd January following judgement delivered on 22nd January 2018.

He further explained that this distrain was a last resort the Service resulted to after series of dialogues with the Bank on their outstanding established liability on Withholding Tax on Bank Interest for the years 2013 and 2014 in the sum of Thirty Million, Sixty Eight Thousand, Four Hundred and Seventy One Naira (30,068,471,22).
