DID YOU KNOW?

- A tax return is a report which contains the relevant tax information of an individual or corporate entity for a specified period in compliance with the relevant tax laws.
- Tax returns allow taxpayers to calculate their tax liability and remit payments or request refunds as the case may be.
- Filing of tax returns with the Relevant Tax Authority (RTA) is a legal obligation for every taxpayer.
- Employers are required to deduct and remit the Personal Income Tax (PIT) of their employees through the Pay-As-You-Earn (PAYE) system monthly
- According to the Personal Income Tax Act (PITA), 2011 (as amended), every employer of labour is required to file a return with the Relevant Tax Authority, not later than 31st January of every year, in respect of PAYE

- deductions made from its employees' income in the preceding year.
- Failure by any employer to file annual tax returns is a penalty of N500,000 on conviction in the case of a corporate body and N50,000 in the case of an individual.
- PAYE returns must be submitted each month on or before the 10th day of the month following the month in which the tax was deducted
- Each State Internal Revenue Service in Nigeria has its prescribed format for employers to file annual tax returns.
- Employers in Kwara State are expected to file their annual tax returns via the Kwara State Internal Revenue Service Self-Service Portal (KW-IRS SSP) at www.sAelfservice.kwirs.com
- Taxpayers are to download, fill and upload the completed annual tax returns form on the portal..
